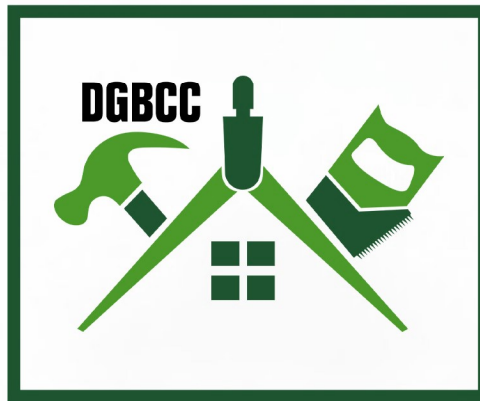

CORPORATE CONCISE

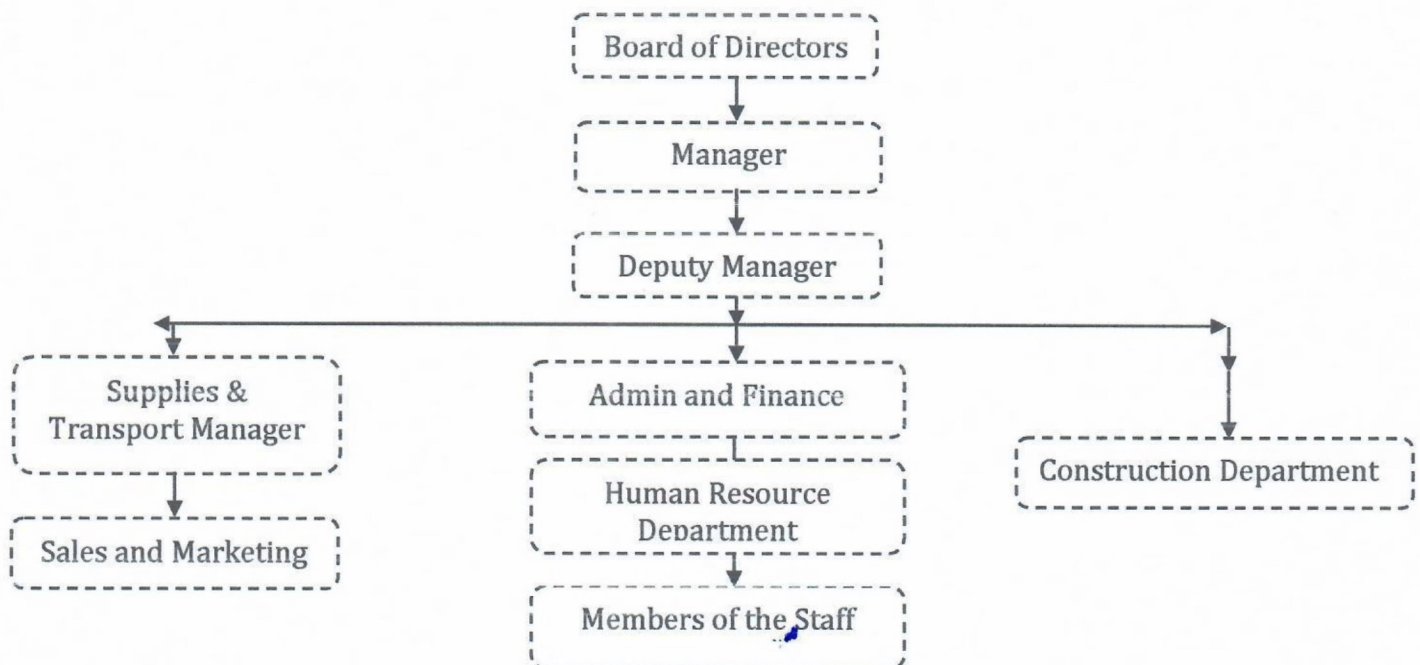

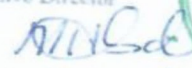
ORGANIZATION STRUCTURE

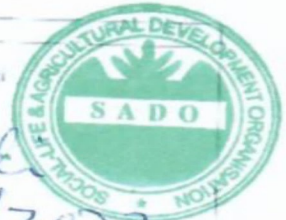
